The following pages from the first to the thirty-fourth inclusive, is a list Invoice and Valuation of the rateable Polls and Estates within the Town of Stoughton, taken by us the subscribers Assessors of said Town, according to law. And also an assessment of taxes on the same amounting to six thousand five hundred and sixty two dollars and eleven cents, including the sum of thirty-nine dollars and forty-nine cents, being the overlaying on said taxes, it being the town and county tax, for the year one thousand eight hundred and fifty.

Which we have this day committed to Enos Talbot, Treasurer and Collector of taxes for said Town, with a warrant in due form of law for collecting the same.
